Why

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and ACCOUNT BALANCES
- INCOME and EMPLOYMENT INFORMATION
- CREDIT HISTORY and CREDIT SCORES

When you are no longer our customer, we continue to share your information as described in this notice.

How

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies</p> <ul style="list-style-type: none"> ■ We have no Affiliates.
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ KellyCars Inc., does not share with Non affiliates so they can market to you such as financial companies, warranty company, and manufacturers.
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ■ KellyCars inc., does not joint market.
